SUBJECT : POSTING OF PCF AND LGSF - SUPPORTED LGU PROJECTS
AND DILG REPRESENTATION IN GROUNDBREAKING AND
INAUGURATION OF SAID PROJECTS

The Government is continuously advocating for transparency and accountability. In line with this thrust, the Department of the Interior and Local Government (DILG) sustains its intensified campaign for transparency through its Full Disclosure Policy through posting of financial transactions and relevant information in conspicuous places.

For CY 2012, the Department is reiterating its policy giving premium on disclosure of information of projects implemented and funded by the Performance Challenge Fund (PCF) and the Local Government Support Fund (LGSF).

In view hereof, all Local Chief Executives are hereby enjoined to post their projects funded out of or supported by PCF and LGSF using any of these formats such as billboard, tarpaulin, banner or poster.

Design and posting of the signage should be guided by the following:


1. Signage Size (4 ft x 4 ft; 4ft x 8 ft; or 8 ft x 12 ft)
2. Signage should be placed in areas where the project is being constructed or implemented.

3. Signage should contain the following information (please refer to the attached template, or go to the DILG PCF website at <http://www.dilg.gov.ph/pcf> for a soft copy of the template)
 - a. Name of Project
 - b. Location
 - c. Project Cost
 - d. Start of Project
 - e. Target Date of Completion
 - f. If the project is funded and/or supported by the PCF, indicate in the signage "**Source of Fund : PERFORMANCE CHALLENGE FUND (PCF) – DILG**"
 - g. If the project is funded and/or supported by the LGSF, indicate in the signage "**Source of Fund: LOCAL GOVERNMENT SUPPORT FUND (LGSF) – DILG**"
4. All project signages in the form of posters, tarpaulin, banners and billboards **SHOULD NOT** contain a picture or name of any person.

Further, in continuance of the Department's all out engagement in the implementation of LGU PCF and LGSF – supported projects, Regional Offices shall submit to the Office of the Undersecretary for Local Government schedule of PCF/LGSF groundbreaking activities and inauguration ceremonies of completed projects and shall ensure that the DILG is represented in these activities.

All DILG Regional Directors are hereby directed to cause the widest dissemination of this Circular.
